At the Full Council meeting on the 15^{th} January 2018 Holton-le-Clay Parish Council set the precept request for 2018/19 at £58,000.

Once again, there has been no change from last year's figure.

The Parish Council have carefully considered the needs of Holton-le-Clay when setting the precept amount and are pleased that they are able to keep the precept at the same level as last year.

The Parish Council have had to make some very tough decisions and make budget cuts where possible to lessen the financial impact on residents.

The necessary budget for 2018/19 is £69,888 the £11,888.00 shortfall will be met by the income from solar Panels on the Village Hall and existing Council funds.

As of March 31st 2018 the Parish Council held funds of: **General Account:** £77,633 (of which £13000 compulsory reserves)

Burial Account £7498 (For Cemetery upkeep)

The 2017/18 Annual return will be published online in early June, following which it will be available for inspection at the Council offices by appointment.
