- NOMINATION PAPERS:** Nomination papers may be obtained from the offices of the Parish Clerk or the Returning Officer, Room 3, Council Offices, Tedder Hall, Manby Park, Louth LN11 8UP on Monday to Friday between the hours of 10am and 4pm (excluding Bank Holidays), who will, at the request of any elector for the Parish prepare a nomination paper for signature.
- DELIVERY OF THE NOMINATION PAPERS:** Nomination Papers must be delivered **by hand** to the Returning Officer, Room 3, Council Offices, Tedder Hall, Manby Park, Louth LN11 8UP, on any day after the date of this notice, on Monday to Friday between the hours of 10am and 4pm (excluding Bank Holidays), but no later than **4 pm on Wednesday, 3rd April 2019.**
- POLL:** If the election is contested, a poll will take place on **Thursday, 2nd May 2019.**
- REGISTER TO VOTE:** Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Friday 12th April 2019.** Applications can be made online: **www.gov.uk/register-to-vote**.
- ABSENT VOTES (POSTAL AND PROXIES):** Electors and their proxies should take note that new applications for a postal vote or to change or cancel an existing postal vote or proxy appointment must reach the Electoral Registration Officer by **5 pm on Monday, 15th April 2019.** Applications for new proxy appointments must reach the Electoral Registration Officer by **5 pm on Wednesday, 24th April 2019.**
- EMERGENCY PROXY VOTES:** Application to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer by **Thursday, 2nd May 2019.** The physical incapacity must have occurred after **5 pm on Wednesday, 24th April 2019.** To apply on the grounds of work/service the person must have become aware that they cannot go to the polling station in person after **5 pm on Wednesday, 24th April 2019.**
