NDP – Clive Keble Consultancy is working on the plan. He has submitted one invoice for work already completed. He is hoping to submit further work by the end of the month.

202.PROPOSED BY COUNCILLOR GREEN TO PURCHASE ADDITIONAL CAMERAS AS AND WHEN FUNDS ALLOW FOR INSTALLATION IN OTHER AREAS OF THE VILLAGE SUCH AS THE TENNIS COURTS, THE TRIM TRAIL, THE CEMETERY AND ANY FLY TIPPING HOTSPOTS. CAMERAS COST £293.99 EACH

Councillor Boon made a counter proposal to purchase 2 cameras when funds become available.

- EIBE £49761.21 NO MENTION OF VAT. THIS COMPANY WAS INVITED TO PROVIDE A QUOTE MORE FOR THE SKATE PARK SIDE OF THE PROJECT.

PROPOSED BY COUNCILLOR BOON THAT HLC PARISH COUNCIL AGREES A POSITION ON THE TOLL BAR ROUNDABOUT PLAN TO COMMENT ON NELC'S PLANNING PORTAL – THAT THERE IS A WISH TO SEE THE PROPOSED TOUCAN CROSSING FROM THE SOUTH OF STATION ROAD TO THE SCHOOL GATES IS COMPLETED ASAP. FURTHERMORE, THAT THE EXISTING FOOTPATH TO THE WEST OF THE A16 IS EXTENDED AROUND THE BEND TO THE PROPOSED CROSSING POINT AND BARRIERS FITTED TO ENCOURAGE CHILDREN CROSSING THE NEW JUNCTION SAFELY:
